- There were \$7,416 purchase of service for acute care days at Mt. Rogers
- Medicaid revenue is down slightly from budget but up significantly over prior year
- Client assistance expense is up related to Part-C and Early Intervention
- Staff development expense is high related to SOR and EMDR trainings
- Supplies are up due to Vivitrol expense
- Communication expense is significantly down from budget related to a change in vendors for telephone services

Delores Belcher reviewed the June 2022 financial report and Kim Howell presented it to the board members. Margaret Gibson made a motion to file the financial report as presented, Robert Ledford seconded the motion and it passed unanimously.
