Call to order

II. Additions or changes to the agenda

III. Public Comment

There was no public comment.

IV. Secretary's Report

Margaret Gibson made a motion to approve the February 22, 2023 minutes as presented, Robert Ledford seconded the motion and it passed unanimously.

### V. Financial Report

Kristie Hammonds presented the Frontier Health February 2023 financial report.

- For February FY23 Virginia services had a profit of \$7,208 with a balance of \$580,165 year-to-date.
- Virginia is continuing to have a good year, with rate enhancements, relatively low turnover, new programs, and capital funding being brought-in for Hawthorne.
   Funding was brought-in for the OBRA van as well as the call center expansion.
- Unfavorable variance from budget in State & Federal is driven primarily by salary expense being under budget.
- Fee for service revenue was up 6.7% from prior year, and down 1.5% from budget.

Margaret Gibson reviewed the February 2023 PD1 financial report and Kim Howell presented it to the board members. Robert Ledford made a motion to file the financial report as presented, Delores Belcher seconded the motion and it passed unanimously.

# VI. Chair Report

Frontier Health will be having a drop in open house from 3 to 5 pm on Wednesday, April 26, 2023, at Hawthorne Place at 500 Hawthorne Drive in Norton, VA. The PD1 Board of Directors meeting will follow at 5 pm at that location.

#### VII. Service Outcomes

Megan Herron reviewed the service outcomes data with 27 hospital admissions for February 2023.

In Region 3 for current fiscal year, PD1 had the lowest number of emergency evaluations resulting in temporary detention orders at 14%.

### VIII. Executive Director Report

- Sandy O'Dell announced an open forum meeting at Highlands Community College on April 8, 2023, from 2:00 to 3:30 pm to discuss Opioid Abatement money. Ms. O'Dell invited everyone to attend and will email an invitation with a registration link for anyone who would like to attend.
- The General Assembly has asked for input from the Community Services Boards regarding work force issues to review at the next session.
- Discussed funding that UVA Wise and MECC will receive for Internship placements.
- Frontier Health will implement a new electronic health record on April 3, 2023. The
  Department of Behavioral Health and Developmental Services will change their data
  collection system in July.
- The Virginia General Assembly has not approved a state budget. Request for local funding has been sent to localities and additional funding may need to be requested once a budget is finalized.

### IX. Service Reports

Eric Greene reviewed the January 2023 Mental Health, Substance Abuse and Intellectual Disabilities Statistical report. Service numbers had an increase in January.

## X. Values TFC Fee Schedule

Robert Ledford made a motion to approve the fee schedule as presented by Kristie Hammonds effective July 1, 2023, Mavis Spivey seconded the motion and it passed unanimously.

#### XI. Frontier Health Report

- Kristie Hammonds announced a follow up meeting has been scheduled on April 27 with County leaders to present proposals regarding the Opioid Abatement money.
- Discussed staff retention. Frontier Health currently has a 27.8% turnover.
- VALUES TFC currently has 11 families serving 9 children.
- Discussed the new Hawthorne location and new programs.
